## AIMS AND OBJECTIVES

The Journal aims to publish the best research on international development issues in a form that is accessible to practitioners and policy-makers as well as to an academic audience. The main focus is on the social sciences - economics, politics, international relations, sociology and anthropology, as well as development studies - but we also welcome articles that blend the natural and social sciences in addressing the challenges for development. The Journal does not represent any particular school, analytical technique or methodological approach, but aims to publish high quality contributions to ideas, frameworks, policy and practice, including in transitional countries and underdeveloped areas of the Global North as well as the Global South. The Journal has two special features: Field Reports, which are short articles contributing to development policy and practice, and invited Policy Arenas, which comprise several articles focusing on a theme with a policy dimension. The Journal is published in association with the Development Studies Association.

## NOTES FOR CONTRIBUTORS

**Manuscript Submission.** The *Journal of International Development* operates an online submission and peer review system that allows authors to submit articles online and track their progress via a web interface. Please read the remainder of these instructions to authors and then click <http://mc.manuscriptcentral.com/joid> to navigate to the *Journal of International Development* online submission site. **IMPORTANT:** Please check whether you already have an account in the system before trying to create a new one. If you have reviewed or authored for the journal in the past year it is likely that you will have had an account created.

**All papers must be submitted via the online system.**

**File Types.** Preferred formats for the text and tables of your manuscript are .doc, .docx, .rtf, .ppt, .xls. **LaTeX** files may be submitted provided that an .eps or .pdf file is provided in addition to the source files. Figures may be provided in .tiff or .eps format.

● **Initial Submission:** NON-LATEX USERS: Upload your manuscript files. At this stage further source files do not need to be uploaded.

LATEX USERS: For reviewing purposes you should upload either a single .pdf that you have generated from your source files. You must use the File Designation "Main Document" from the dropdown box.

● **Submission of a Revised Manuscript:** NON-LATEX USERS: Editable source files must be uploaded at this stage. Tables must be on separate pages after the reference list, and not be incorporated into the main text. Figures should be uploaded as separate figure files. LATEX USERS: When submitting your revision you must still upload a single .pdf that you have generated from your now revised source files. You must use the File Designation "Main Document" from the dropdown box. In addition you must upload your TeX source files. For all your source files you must use the File Designation "Supplementary Material not for review". Previous versions of the uploaded documents must be deleted. If your manuscript is accepted for publication we will use the files you upload to typeset your article within a totally digital workflow.

### Copyright and Permissions

● A completed copyright agreement is required before your article can be published. If you have not already completed this using Wiley Author Licensing Service (WALS) please login to <http://authorservices.wiley.com/bauthor/> to complete your copyright form online.

● **Permission grants** - if the manuscript contains extracts, including illustrations, from other copyright works (including material from online or intranet sources) it is the author's responsibility to obtain written permission from the owners of the publishing rights to reproduce such extracts using the Wiley [Permission Request Form](#).

The Copyright Transfer Agreement Form and the Permissions Request Form should be uploaded as "Supplementary files not for review" with the online submission of your article.

If you do not have access to a scanner, further instructions will be given to you after acceptance of the manuscript.

Submission of a manuscript will be held to imply that it contains original unpublished work and is not being submitted for publication elsewhere at the same time.

**IMPORTANT:** This journal operates a double blind reviewing process whereby the Reviewer is not aware of the Author's identity. In order to facilitate this please follow the instructions below very carefully. Ensure your manuscript text does not contain any direct reference to you or your co-Authors. Upload the main text of your manuscript with the file designation Main Document. The title page should contain just the title and keywords. Upload a secondary title page as a separate document. Use the file designation Supplementary Material Not for Review. The secondary title page should contain the article title and full names and address of all authors.

**Manuscript Style.** The language of the journal is English. All submissions including book reviews must have a title, and have a margin of 3cm all round. Illustrations and tables must be on separate sheets, and not be incorporated into the text.

● The **title page** must list the full title, and names and affiliations of all authors. Give the full address, including email, telephone and fax, of the author who is to check the proofs.

● Include the name(s) of any **sponsor(s)** of the research contained in the paper, along with grant number(s).

● Supply an **abstract** of up to approximately 100 words for all articles [except book reviews]. An abstract is a concise summary of the whole paper, not just the conclusions, and is understandable without reference to the rest of the paper. It should contain no citation to other published work. Include up to 8 **keywords** that describe your paper for indexing purposes.

● Articles must not exceed 8000 words (exclusive of abstract, references, tables and figures). Short Notes or 'Field Reports', which summarise a finding in not more than 1000 words, are particularly welcome. Review articles are also encouraged but must not exceed 10,000 words.

● Spelling should follow that of the Oxford English Dictionary or Webster's Third New International Dictionary.

**English Checking Service for Authors in Asia (from non-English-speaking countries)** A list of recommended English editing services is available for authors who want to have their papers checked and improved before submission. **Reference Style.** References should be quoted in the text as name and year within brackets and listed at the end of the paper alphabetically. Where reference is made to more than one work by the same author published in the same year, identify each citation in the text as follows: (Mosley, 1998a), (Mosley, 1998b). Where references include three or more authors the form (Mosley *et al.*, 1998) should be used in the text.

All references must be complete and accurate. Where possible the DOI for the reference should be included at the end of the reference. Online citations should include date of access. If necessary, cite unpublished or personal work in the text but do not include it in the reference list. References should be listed in the following style:

**Illustrations.** Upload each figure as a separate file in either .tiff or .eps format, with the lead author's name, the figure number and the top of the figure indicated. Compound figures e.g. 1a, b, c should be uploaded as one figure. Tints are not acceptable. Lettering must be of a reasonable size that would still be clearly legible upon reduction, and consistent within each figure and set of figures. Where a key to symbols is required, please include this in the artwork itself, not in the figure legend. All illustrations must be supplied at the correct resolution:

- Black and white and colour photos - 300 dpi
- Graphs, drawings, etc - 800 dpi preferred; 600 dpi minimum
- Combinations of photos and drawings (black and white and colour) - 500 dpi

Tables should be part of the the main document and should be placed after the references. If the table is created in excel the file should be uploaded separately.

The cost of printing **colour** illustrations in the journal will be charged to the author. If colour illustrations are supplied electronically in either TIFF or EPS format, they may be used in the PDF of the article at no cost to the author, even if this illustration was printed in black and white in the journal. The PDF will appear on the *Wiley Online Library* site.

**Further Information.** For accepted manuscripts the publisher will supply proofs to the submitting author prior to publication. This stage is to be used only to correct errors that may have been introduced during the production process. Prompt return of the corrected proofs, preferably within two days of receipt, will minimise the risk of the paper being held over to a later issue. Free access to the final PDF offprint of your article will be available via author services only. Please therefore sign up for author services if you would like to access your article PDF offprint and enjoy the many other benefits the service offers.
